INSTRUCTIONS TO BIDDERS

1. BID BOND

Bid bond or certified check for Five Hundred dollars (\$500.00) must be submitted with the bid, the undersigned agrees that the bid security may be retained by the County until contracts have been signed and Performance Bonds have been delivered to the County. Should the successful bidder to whom the bid awarded fail to execute the agreement submitted by the County in accordance with the formal bid and other contract documents and to furnish the required performance bond within fourteen (14) calendar days after the notice of award, the certified check or the bid bond amount shall be forfeited to the County as liquidated damages caused by such failure.

2. PERFORMANCE BOND

The successful bidder or bidders shall, within two weeks after notice of the award, enter into a contract with Cattaraugus County and furnish a performance bond running to the County of Cattaraugus in the amount of FIVE THOUSAND DOLLARS (\$5,000), in a format acceptable to the Cattaraugus County Attorney.

3. BID FORM

Bid shall be submitted on these Cattaraugus County bid forms or bid will not be considered. Bid must be typed or printed in ink. Original autograph signatures in ink are required. Facsimile or rubber stamp signatures will not be accepted. All blanks must be filled in with required information or, if a bid item, the designation N/B (no bid).

4. <u>CHANGES</u>

Any change in wording or interlineation by a bidder of the inquiry as published by Cattaraugus County shall be reason to reject the proposal of such bidder, or in the event that such change in the Invitation to Bid is not discovered prior to entering into a contract, to void any contract entered into pursuant to such bid.

5. INFORMALITIES

The County may consider informal any bid not prepared and submitted in accordance with the provisions hereof and may waive any informalities or reject any and all bids. The contract award will be made to the responsible bidder submitting the lowest acceptable bid. Conditional bids will not be accepted.

6. BID TIME

Any bid may be withdrawn prior to the above scheduled time for the opening of bids, or authorized postponement thereof. Any bid received after the time specified shall not be considered.

7. INVESTIGATIONS

The County may make such investigations as it deems necessary to determine the ability of the bidder to perform the work, and the bidder shall furnish to the County all such information and data for this purpose as the County may request. The County reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy the County that such bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein.

8. BID ENVELOPE

Each bid must be submitted in a sealed envelope clearly marked as to contents therein, bearing on the outside the name and address of the bidder. If sent by mail, the sealed envelope containing the bid must be enclosed in another envelope labeled as specified.

9. NON-COLLUSIVE CERTIFICATION

Non-collusive bidding certification shall be made by each bidder in the form provided and shall be submitted as a part of the bid. Bids submitted without non-collusive bidding certification will be considered irregular and may be rejected by the County.

10. CONTRACT AWARD

Contract(s) or purchase order(s) will be awarded after due consideration of the suitability of goods and/or services bid to satisfy these specifications, the total cost of such goods and/or services including all cost elements, and the timeliness of the agreed delivery date.

11. REFERENCES

A list of references, including at least one reference located in Western New York, for whom the bidder has done work in the past must accompany the bid.

12. EXECUTORY CLAUSE

This executory clause shall be a part of any agreement entered into pursuant to this bid:

It is understood by the parties that this agreement shall be executory only to the extent of the monies available to the County of Cattaraugus and appropriated therefor, and no liability on account thereof shall be incurred by the County beyond the monies available and appropriated for the purpose thereof.

13. DELIVERY SCHEDULE

Failure to meet delivery schedule as per accepted bid may result in legal action by Cattaraugus County to recover damages.

14. PRICES

Prices shall be quoted F.O.B. destination, delivered inside and installed, or as otherwise specified in these specifications. "Tailgate delivery" will not be accepted unless specified by the County.

15. TRANSPORTATION CHARGES

Collect transportation charges will not be paid by the County. All freight, cartage, rigging, postage or other transportation charges shall be prepaid, unless otherwise stated in the Detailed Specifications herein.

16. TAXES

No taxes are to be billed to the County. Bid shall not include any Federal, State, or local excise, sales, transportation, or other tax unless Federal or State law specifically levies such tax on purchases made by a political subdivision. Any applicable taxes from which the County is <u>not</u> exempt shall be listed separately as cost elements, and added into the total net bid.

17. COMPLIANCE WITH LAWS

The successful bidder shall comply with all laws, rules, regulations and ordinances of the Federal Government, the State of New York and any other political subdivision or regulatory body which may apply to its performance under this contract.

HAZARD COMMUNICATION. In complying with the above laws, rules and regulations, and pursuant to 12 NYCRR Part 820 and Section 876 of the Labor Law, it is the responsibility of the County to provide the successful bidder with the following information:

- (a) the material safety data sheets (MSDS) for any hazardous chemicals to which employees may be exposed will be made available,
- (b) the telephone numbers of plant personnel who are to be contacted in the event of a chemical spill or accident, and,
- (c) emergency procedures in the event of a fire or spill.

MATERIAL SAFETY DATA SHEETS. The successful bidder shall be responsible for the provision of the MSDSs to the County prior to introducing hazardous materials onto the site, assuring compliance before work is started, and disseminating any information to County employees concerning significant chemical hazards that the successful bidder is bringing to the County's workplace. The MSDSs will be obtained from the successful bidder for all hazardous materials prior to bringing the materials on the site. These MSDSs will be maintained by the County as long as those materials are present. It is the responsibility of the successful bidder to train its own employees.

18. DISCRIMINATION

The successful bidder agrees:

- (a) that in the hiring of employees for the performance of work under this contract or any subcontract hereunder, no contractor, subcontractor, nor any person acting on behalf of such contractor or subcontractor, shall by reason of race, creed, color, sex or national origin discriminate against any citizen of the State of New York who is qualified and available to perform the work to which the employment relates;
- (b) that no contractor, subcontractor, nor any person on his behalf shall, in any manner, discriminate against or intimidate any employee hired for the performance of work under this contract on account of race, creed, color, sex or national origin;
- (c) that there may be deducted from the amount payable to the contractor by Cattaraugus County under this contract a penalty of fifty dollars for each person for each calendar day during which such person was discriminated against or intimidated in violation of the provisions of the contract;
- (d) that this contract may be canceled or terminated by Cattaraugus County and all monies due or to become due hereunder may be forfeited, for a second or any subsequent violation of the terms or conditions of this section of the contract; and
- (e) the aforesaid provisions of this section covering every contract for or on behalf of Cattaraugus County for the manufacture, sale or distribution of materials, equipment or supplies shall be limited to operations performed within the territorial limits of the State of New York.

(N.Y. State Labor Law Article 8 Section 220-e)

19. CONTRACT ASSIGNMENTS

The bidder shall not assign, transfer, sublet, or otherwise dispose of this contract, or of its right, title or interest in the contract, or its power to execute the same, to any other person or corporation without the previous consent, in writing, of the Chairman of the Cattaraugus County Legislature.

20. CASH DISCOUNT

Any cash discount which is a part of a bid will be considered as a reduction in the bid prices in determining the award of the bid. Date of invoice must not precede date of delivery. The County policy is to pay all claims in a timely manner within the specified time. However, if for some reason payment is delayed, the County will take the discount when payment is made. If this is unsatisfactory, please quote net. The County will not pay any interest charges.

21. MANUFACTURERS

Where required on an individual bid sheet the bidder must specify the trade name of the material on which the price is quoted.

22. ALTERNATE MANUFACTURERS

Bid offering material other than that of specified manufacturer or trade name will be considered unless stated otherwise. The use of the name of a particular manufacturer, trade name, or brand in describing an item does not restrict a bidder to that manufacturer or specific article. However, the substituted article on which a proposal is submitted must be of such character or quality that it would serve the purpose for which it is to be used equally as well as the manufacturer or brand specified. Proposals will be accepted in accordance with specifications on file or approved equal.

23. ALTERNATE ITEMS

If material or services other than those specified in this bid document are offered, the bidder must so state and furnish at the time of bid opening, if so requested, and as part of his bid the following information in duplicate:

- (a) Complete description of the item offered, and detailed explanation of the differences between the item specified and the item offered. If, in the opinion of the Department Head, sufficient detail is not presented as a part of the sealed bid to permit definite evaluation of any substitute item, the bid will not be considered.
- (b) Descriptive literature of item offered, for evaluation.
- (c) List of installations in Cattaraugus County of the item offered.
- (d) List of other installations.

24. ADDITIONAL INFORMATION

Any additional information which bidder desires to add to the bid shall be written on a separate sheet of paper, attached to and submitted with the formal sealed bid, to be read at the formal opening.

25. WORKMANSHIP

Workmanship must meet with the approval of the department head or heads involved, and shall be first class in every respect without exception and shall be equal to the best modern practices. Materials furnished are to be new and unused. All materials furnished or work performed are to be guaranteed free from defects. Anything found defective or not meeting specifications, no matter in what state of completion may be rejected and shall be made good by the contractor at his own expense.

26. HOLD HARMLESS

The successful bidder to whom the bid is awarded shall

indemnify and hold harmless Cattaraugus County and its agents and employees from and against all claims, damages, losses or causes of action arising out of or resulting from such vendor's performance pursuant to this bid.

27. BID VALIDITY

This bid is firm and irrevocable for a period of 45 days from the date and time of the bid opening. If a contract is not awarded within the 45 day period, a bidder to whom the bid has not been awarded, may withdraw his bid by serving written notice of his intention to do so upon the Clerk of the County Legislature. Upon withdrawal of the bid pursuant to this paragraph, the County will forthwith return the bidder's security deposit.

28. CONTRACT INTEREST

No official, or employee of the County, who is authorized in such capacity, and on behalf of the County, to negotiate, make, accept or approve or to take part in negotiating, making, accepting, or approving this contract shall become directly or indirectly interested personally in this contract or in any part hereof. No officer or employee of, or for the County, who is authorized in such capacity, and on behalf of the County, to exercise any supervisory, administrative, or other function, in connection with this contract, shall become directly or indirectly interested personally in this contract or any part hereof.

29. OTHER CUSTOMERS

Prices charged to Cattaraugus County are to be <u>no higher</u> than those offered to any other governmental or commercial consumer. If a bidder has a New York State or a Federal GSA contract for any of the items covered in this bid or any similar items, he shall so indicate that he has said contract on these bid papers and supply a copy of this contract within 5 days if so requested by the County.

30. PRICE IS FIRM

The unit prices bid shall remain firm, and any other charges bid shall also remain firm, for delivery of the equipment, material, work, or services described in this bid with the exception of the asphalt, diesel fuel, kerosene and gasoline bids, which are permitted escalator prices in accordance with the detailed specifications for those products. No cost increase shall be charged for any reason whatsoever.

31. BIDDER AFFIRMATION

In executing this bid, the bidder affirms that all of the requirements of the specifications are understood and accepted by the bidder, and that the prices quoted include all required materials and services. The undersigned has checked all of the bid figures, and understands that the County will not be responsible for any errors or omissions on the part of the

undersigned in preparing this bid. Mistakes or errors in the estimates, calculations or preparation of the bid shall not be grounds for the withdrawal or correction of the bid or bid security. In case of error in extension of prices in the bid, the unit price will govern.

32. <u>LITIGATION:</u>

In the event any litigation shall arise from this contract, the laws of the State of New York shall control any litigation, regardless of which party shall institute such action.

33. TERMINATION:

The County may terminate the contract immediately in the event the Contractor fails to comply with any terms of the contract. The contract may be terminated at any time by either party upon the giving of thirty (30) days written notice to the other party; however, in the event the Contractor defaults in the performance of any of its obligations under this contract, the County may terminate the contract effective upon written notice at any time.

34. INSURANCE

The (Contractor, Vendor, Etc.) shall secure and maintain, at its own cost and expense, insurance coverage specified in Appendix (A) attached hereto, complying with Classification "(selected on form)", with insurance companies licensed in the State of New York. Cattaraugus County must be named as an additional insured for purposes of coverage, but not for payment of premium. The (Contractor, Vendor, Etc.) shall file a certificate of insurance with the Cattaraugus County Risk Manager covering all acts performed by the (Contractor, Vendor, Etc.) prior to performing pursuant to this Agreement or receiving any payment thereunder and shall be responsible for updating the certificate as necessary throughout the term of the Agreement. All certificates of insurance shall provide that Cattaraugus County be given thirty (30) days' notice prior to non-renewal or cancellation of these policies. Certificate of Insurance shall be furnished by the bidder within five (5) days of the "Intent to Award" and prior to signing of contract. Failure to supply a satisfactory certificate within five (5) days after the "Intent to Award" may result in the cancellation of award and for the forfeiture of the Contractor's bid security, in the sole discretion of the County.

35. STATE CONTRACTS:

The County reserves the right to purchase the commodity being bid, from State Contract when it is most beneficial to the County to do so.

36. WAGE RATES

Construction, reconstruction, or repair contracts for public works facilities are subject to minimum wage rates, as established by the State of New York Department of Labor. The successful bidder on any contract for public works to which the provisions of the New York State Labor Law Article 8 apply agrees that:

- (a) No laborer, workman or mechanic in the employ of the contractor, subcontractor or other person doing or contracting to do the whole or part of the work contemplated by the contract shall be permitted or required to work more than eight hours in any one calendar day or more than five days in any one week except in cases of extraordinary emergency including fire, flood or danger to life or property. (Section 220, subd. 2, N.Y. State Labor Law)
- (b) Each laborer, workman, or mechanic employed by the contractor, subcontractor or other person doing or contracting to do the whole or part of the work contemplated by the contract shall be paid not less than the hourly minimum rate of wage and provided supplements not less than the prevailing supplements as designated by the New York State Industrial Commission.

(Section 220, subd. 3, N.Y. State Labor Law) A schedule of prevailing hourly wage rates is attached to this packet.

37. MUNICIPAL EXTENSION:

The contract if awarded will be to the lowest responsive/responsible bidder(s) in part or in whole who meet(s) all the terms of the specifications. The County guarantees no minimum or maximum purchases or contracts as a result of award of this bid. Cattaraugus County reserves the right to allow all municipal and not for profit organizations authorized under the General Municipal Laws of the State of New York, to purchase any goods (materials and equipment) and/or services awarded as a result of this bid in accordance with the latest amendments to NYS GML 100 through 104 and County Law Section 408-a. However, it is understood that the extension of such contracts are at the discretion of the vendor and the vendor is only bound to the contract between Cattaraugus County and the vendor.

SPECIFICATIONS FOR

HVAC AND REFRIGERATION SYSTEMS INSPECTION, TESTING & MAINTENANCE

GENERAL

1. SCOPE OF THE SPECIFICATIONS.

The purpose of these specifications is to provide routine HVAC (Heating, Ventilation, and Air Conditioning) and refrigeration inspection, testing and maintenance for Cattaraugus County, which includes; Department of Public Works facility, Dept. of Social Services Building, and the County Center Building and Jail, in Little Valley, the Cattaraugus County Building at 1Leo Moss Drive, Olean, The Pines Healthcare & Rehabilitation Centers, (former County Nursing Homes) in Olean and Machias, and the Stone House in Machias (next to the Pines Healthcare & Rehabilitation - Machias) for the County of Cattaraugus, located in New York State. <u>ALL INSPECTIONS, TESTING AND MAINTENANCE SHALL BE DONE ACCORDING TO THE STANDARDS OF THE INDUSTRY</u>.

2. <u>TERMS OF THE CONTRACT</u>.

The contract shall be effective for a FOUR YEAR term (two, 2 year periods) beginning **January 1, 2017**.

3. DOCUMENTS FORMING THE CONTRACT.

The contract shall be deemed to include the Notice to Bidders, Instructions to Bidders, Specification Bid Sheet, Legal Status Sheet and Non-Collusive Bid Certification.

- 4. The contract will be awarded in two parts. All items in <u>Part A</u> will be awarded to one contractor that submits the lowest "TOTAL OF ALL SITES" (for the four (4) years) bid for Basic Service which includes the inspecting, testing, and maintenance of HVAC and refrigeration systems, per the specifications of Cattaraugus County <u>PLUS</u> 180 hours per year times the Hourly Rate. Part B is for Pines Healthcare and Rehab Center Machias and will be awarded separately from Part A, based on lowest price bid for either "TOTAL SERVICE" OR "BASIC SERVICE <u>PLUS</u> 180 Hours per year times Hourly Rate" at the county's discretion.
- 5. The County will NOT PAY additional service or delivery charges such as FUEL SURCHARGES.

6. BIDDER'S QUALIFICATIONS.

- A) Bidder must be skilled and experienced in the class of work proposed and shall be required to furnish evidence of financial ability and of similar work satisfactorily completed.
- B) The bidder shall also be required to show evidence of sufficient machinery and equipment to do the work called for in these specifications within the specified time.
- C) The bidder must have a qualified service facility in a location which will insure the County of having available rapid, efficient service within four (4) hours of notification.
- D) The bidder must have available from his facility at least one (1) mobile shop equipped with all necessary supplies and equipment to make inspection, repairs, and necessary testing of HVAC & refrigeration equipment.
- E) The bidder shall be a qualified HVAC and refrigeration company with full understanding of all HVAC & refrigeration standards and regulations of this work.
- F) The bidder shall maintain a central supply stock of normal parts and testing and inspection equipment at his main facility to enable him to supply at least 90% of his repair parts directly from that facility without further parts order.
- G) Bidder must have been in business under the same business name for at least a five (5) year period preceding the date of bid, to insure stability of service to Cattaraugus County.
- H) The bidder shall use only skilled, competent, trained HVAC & refrigeration personnel having a minimum experience of five (5) years in maintaining HVAC & refrigeration systems similar to those in this specification.
- I) The information requested in this section shall be presented with the bid.
- J) Failure to supply such information as requested shall be considered sufficient grounds to reject the bid.

BASIC SERVICE SPECIFICATIONS

7. GENERAL.

The work required under these specifications will be for testing, inspection and the maintenance of HVAC & refrigeration systems in buildings owned by the County of Cattaraugus. The successful bidder shall inspect and maintain the HVAC & refrigeration needs in county buildings at satisfactory levels and in accordance with applicable rules and regulations of relative local, state, federal, OSHA, DEC and EPA laws. Any and all fines or judgments will be born by the contractor. Further, it is intended that the supplies used shall at all times meet, or exceed, the manufacturer's specifications and those of the local and State laws. Installations shall be approved by the Commissioner of Cattaraugus County DPW and/or the department head, when completed.

8. PROVISIONS OF RECORDS.

Records of work performed shall be submitted to the County Maintenance Supervisor, identifying what work was done and which building the work was performed in. Statement of work performed to be printed or typed so as to be <u>legible</u> to all persons.

9. MATERIALS TO BE USED.

Only materials that meet UL Listings and are manufacture approved as substitute shall be used in performing the work described in these specifications. Parts and components shall be functionally equal and/or of better quality and performance than the existing or original equipment.

10. FAILURE TO MEET SPECIFICATIONS.

If there is any deviation from these specifications or failure to perform the conditions of the contract to be entered into, the County of Cattaraugus reserves the right to terminate the contract upon ten (10) days written notice of the breach and failure on the part of the bidder to correct the same.

11. EXCEPTIONS.

Maintenance under this contract does not include the repair or replacement of equipment, at the successful bidder's expense, which has otherwise become defective from damage caused by accidents, physical abuse or misuse of the equipment, act of God, or by fires. Such work will be performed as required at the quoted hourly rate in bid for the specific work involved. ALL ADDITIONAL WORK NOT COVERED BY THIS MAINTENANCE AGREEMENT SHALL BE APPROVED BY THE COUNTY MAINTENANCE SUPERVISOR. A WRITTEN ESTIMATE OF THE COST SHALL BE SUBMITTED TO THE MAINTENANCE SUPERVISOR.

12. COMMUNICATIONS.

All communications for visits other than scheduled routine visits regarding HVAC & refrigeration testing, inspection, and maintenance shall be with the successful bidder or his designated representative. Calls for such work will be by the County Maintenance Supervisor.

13. <u>BUILDINGS AND GROUNDS COVERED UNDER CONTRACTS</u>.

The bidder shall agree, if requested and a contract is entered into, to provide HVAC & refrigeration inspection, testing and maintenance for the various County buildings which include; the County Center Building and Jail, Dept. of Social Services building, and the Dept. of Public Works facility at Little Valley, the County building located at 1Leo Moss Drive, Olean New York, The Pines Healthcare & Rehabilitation Centers, at Olean and Machias, Stonehouse at Machias, at the unit prices quoted in this bid and will adhere to these specifications.

14. VISITATION OF COUNTY FACILITIES:

Each bidder is required to visit each County facility under this contract to totally familiarize himself/herself with the equipment involved in the inspection, testing and maintenance. The prices submitted are to reflect charges to inspect, test and maintain each particular system. Appointments for visiting facilities must be made with maintenance supervisor at each facility.

- It should be understood and noted that the County will be performing various departmental operational functions during the prosecution of any work required by this contract to be performed. The successful bidder is to make all necessary provisions as to make interruptions to any department as infrequent as possible.
