Notice:

- Exhibitors will be supplied with one eight (8) foot table and will be responsible for erecting any other items needed for their area including displays, etc.
- Exhibitors are responsible for reporting the <u>NY Sales Tax</u> where applicable and comply with any applicable State regulations. Exhibitor must clearly display a validated NY Certificate of Authority.
- Vendors will be requested to remain set up for the entire operating times and days of the event.
- Exhibitor understands that exhibits/concessions must be neat and clean, with suitable safety equipment where required.
- Exhibitors are responsible for their own trash disposal which includes large boxes, packing material, signage, etc.
- Exhibitor will stay in its assigned booth space and not occupy/stand in the aisle way or place sign ups/promo items outside of booth space.
- The sponsor will provide the Exhibitor with exhibitor ribbons, which the Exhibitor agrees to use as identification for entrance to WILMA.
- The Exhibitor agrees to obtain and maintain in force, throughout the term of the exhibition, comprehensive general liability insurance against any loss, liability, or damage on, about or relating to the WILMA or the Cattaraugus County Fairgrounds. The Exhibitor shall furnish the sponsor with a certificate of such insurance and a certificate confirming the Exhibitor's workers compensation insurance coverage, together with written evidence that the premiums for such insurance have been paid, prior to the commencement of the exhibition
